# POPE LEO XIV – SHORT BIOGRAPHY

## Early Life and Formation

Born in Chicago into a multicultural Catholic family, Robert Prevost was active in parish life from a young age. He earned a degree in Mathematics from Villanova University in 1977 and joined the Augustinian Order, making his solemn vows in 1981 and being ordained in 1982. He pursued further studies in theology and canon law in Chicago and Rome.

## Missionary Work and Leadership

Fr. Prevost served for many years in Peru, engaging in pastoral and seminary ministry. He became a Peruvian citizen and was elected Prior General of the Augustinian Order (2001–2013). In 2015, Pope Francis appointed him Bishop of Chiclayo, where he was known for his humility and missionary zeal.

## Curial Roles and Election as Pope

In 2023, he was appointed Prefect of the Dicastery for Bishops, President of the Pontifical Commission for Latin America, and made a Cardinal. He was elected Pope on May 8, 2025, and chose the name **Leo XIV**, honoring Popes Leo I and Leo XIII.

## Papal Vision

Pope Leo XIV is a bridge-builder known for pastoral sensitivity and theological depth. He continues the legacy of Pope Francis with a focus on:

- Church reform and transparency
- Empowerment of local churches
- Social justice and care for the poor
- Dialogue with modern society
- Synodality and lay participation

Rooted in Augustinian spirituality, he leads the Church with a global and inclusive vision.

# The Shepherd Speaks

**Dear Fathers, Sisters and Brothers,**

Peace to you all and Prayerful greetings! This issue of June has been delayed intentionally so as to include a comprehensive report on the Diocesan Synod meetings and its solemn conclusion on 8<sup>th</sup> June.

## **Election of the Holy Father: Our greetings and prayers**

Let me begin this month's message expressing our profound gratitude to God for having given to the Universal Church **His Holiness Pope Leo XIV** as the chief Shepherd. We join along with the entire church in rejoicing at this election. God is present in the Church through His Spirit guiding and moving it forward. He knows better what we are truly in need of. He provides to the Church the best Shepherds suited for the times and the needs. We strongly believe this. With gratitude to God, the author of our history, **we extend to our new Holy Father our felicitations, heartfelt greetings and our prayers**. May he be filled with the Spirit of God to lead the Church in the way God wants. This is our wish and prayer for the Holy Father.

## **Diocesan Synod**

Second important event that took place in the last few weeks was our Diocesan Synod (May 26-30). As I began my episcopal ministry in your midst, I found the need of having specific guidelines or statutes for the administration of the Diocese. Although the Universal law contains norms, particular church's context and the needs demand that we prepare our own particular laws suitable and effective for the context. Church grants the authority to formulate or determine norms concerning diocesan administration, pastoral life, liturgical life etc to the local Ordinary. **But in my wish and desire to conform myself to the call of the Holy Father Pope Francis to build a synodal church**, a church that walks together, I wanted to bring out such guidelines **only after consulting the entire diocese**. That is how, the idea of diocesan synod entered into my



thoughts. Then I found that the Code of Canon Law gives a provision in nos. 460-468 to the diocesan Bishop to convoke such a synod to seek advice and counsel for initiating novelty in his administration, in his pastoral endeavours, liturgical life etc.

I have prepared myself for this event by visiting the diocese extensively, meeting our big and small communities, interacting with them, meeting priests and religious thus coming to a comprehensive understanding of the diocese in all its aspects. We have also formed preparatory committees that studied specific areas of diocesan life.

Based on my personal experience, knowledge that I have acquired on every aspect of the diocese, based on what I have heard from people, priests, religious and finally the reports of the preparatory committees I have prepared *Instrumentumlaboris*, the working document titled "*Discerning Synodal Pathways to live as a family of Believers*". This document really guided and helped fruitful discussions in the Synod. We made every encounter during the synod fruitful. We were focussed only on the welfare of the diocese and its future. The 121 Synod members were able to give their opinions, suggestions on every aspect of the diocese freely and constructively. I really felt the guiding hand of God during this one-year journey. He guided every step we took and finally guided every thought and word during the synod. On the last day 30<sup>th</sup> May, I met the entire pastoral clergy to obtain their opinion and counsel concerning their ongoing formation and their welfare. You can see a detailed report in the following pages of this booklet.

Now, based on the counsel, advice and the opinions of the Synod, as well as the *Presbyterium*, I am preparing the post synodal document titled "**Walking together as family of believers: The Pastoral Guide of the Diocese of Kurnool**". **కలని నడిచే విశ్వాస కుటుంబం: కర్నూలు మేత్రాసన పరిపాలనా మరియు పరిచర్య విధి విధానాలు**". Certainly, it would take little more time to compose and publish this long document. However, on 8<sup>th</sup> June, on the day of the Pentecost, we have formally concluded the Synod with the symbolic promulgation of the post synodal document. The Archbishop of Hyderabad, His Eminence **Cardinal Poola Anthony** celebrated the Holy Eucharist of the Pentecost and symbolically released the post synodal document.

## My Sincere Gratitude

I wish to thank everyone that participated in the synodal journey of the diocese and made it a grand success. To the preparatory committees, to the organising committees, to the secretaries, animators, assisting staff, to the participants of the Synod and also to all those who were supporting us through their prayers. It is not my success. It is our Success. We did it as a family and so we can move forward as a family with increased enthusiasm and commitment.

## Appointments and Transfers

As a further indicator of our new beginning and new Pentecost in the Church of Kurnool, we have also made all the appointments in the Diocese and transfers. **Rev. Msgr. David Arulappa is the new Vicar General of the diocese. In addition, Very Rev. Fr. Pasala Joseph, is the Episcopal Vicar for pastoral life of the diocese, Very Rev. Fr. Mesa Prasanna is the Episcopal Vicar for clergy and seminarians, Rev. Fr. O. Jojireddy is the Chancellor, Rev. Fr. Suripogula Thomas is the Procurator etc.** The entire list of the appointments and transfers can be found in later pages. I wish all the best to each one of our priests. They truly manifested the spirit of obedience and love for the Diocese and its people. I am very proud of them and very much impressed by their understanding. My sincere appreciation and gratitude!

Wherever we are or whatever we do, we are doing for Christ who called us and anointed us. Places and positions are all transitory. Nothing is permanent. We are only pilgrims. We keep moving from one place to the other. For that matter, even our lives are transitory. So let us surrender entrust ourselves and our ministries to God and to his providence. We will be effective and content wherever we are and whatever we do, when we surrender ourselves to God and His will. He is the only source of our joy!

## 1. GOLDEN JUBILEE OF REV. SR. GEETHI CTC AT KRISTUJAYANTHI CARMEL BHAVAN

On May 15, 2025, the Carmel Matha Province marked the Golden Jubilee of Rev. Sr. Geethi CTC, completing 50 years of consecrated life. His Lordship Most Rev. Dr. Johannes Gorantla arrived at 6:30 p.m. and was welcomed by the sisters. After a short break, the Jubilee Mass began at 6:45 p.m. with a procession including the Jubilarian. During the homily, the Bishop spoke on



faithfulness in religious life, using the image of the vine and branches to explain the connection with Christ. He also congratulated Sr. Geethion her long service to the congregation. After the Mass, a group photo was taken with the Jubilarian. A felicitation by the Bishop, sisters, and others followed this. A meal was served to all those who attended the celebration.

## 2. FEAST OF NITHYASAHAJAMATHA CELEBRATED AT SIRVEL PARISH

On 24th May 2025, St. Anthony's Church, Sirvel Parish, celebrated the Feast of Nithyasahayamatha. At 10:30 a.m., Bishop Most Rev. Dr. Johannes Gorantla was welcomed at the presbytery with shawl and garland by Parish Priest Rev. Fr. SambaturuPrabhudas, Fr. K. Raju MF, and village elders. From there, he was led to the Grotto of Nithyasahayamatha by the village youth band and firecrackers. During the homily, the Bishop spoke about the role of Mother Mary in interceding for the faithful, while reminding that Jesus is the source of blessings.



After the Mass, Fr. S. Prabhudas thanked God and Mother Mary for the blessings received. He also expressed gratitude to Bishop Johannes for his support to the parish. The Bishop was then honoured by the village elders, Legion of Mary, and parish youth. A citation was read by Prakasham, BCC animator.

About 30 priests and religious from local and nearby parishes took part in the celebration. Fr. Prabhudas thanked all clergy and religious for their participation and prayers. A fellowship meal followed the Mass for all gathered.

### **3. FEAST OF OUR LADY OF PERPETUAL HELP CELEBRATED AT PEDDA KADUBURU**

On May 24, 2025, the community of Peakadabur Parish, St. Peter's Church, welcomed Bishop Most Rev. Dr. Johannes Gorantla for the feast of Our Lady of Perpetual Help. The Bishop joined the faithful in the procession. After the procession, he presided over the Mass for the feast. In his message, the Bishop reminded the people that Mary continues to pray for all. He noted the strong faith of the parishioners. Both the parish and substation communities joined in the celebration. People listened attentively to the Bishop's message. The parish priest expressed thanks to the Bishop, fellow priests, and all the faithful.



# Kurnool Diocesan Synod , May 26– 30, 2025



As we all know, we had been preparing for the Synod from months, in a progressive way. By the middle of April, Bishop received the reports from all the preparatory committees. In the mean time Bishop also determined the membership for the Synod.

The General Assembly of the Synod that began on 26<sup>th</sup> May came to a conclusion on 30<sup>th</sup> May. But the actual and official conclusion was celebrated on 8<sup>th</sup> June, the Solemnity of the Pentecost with the promulgation of the post-synodal document: **"Walking together as a family of Believers: The Pastoral Guide of the Diocese of Kurnool"**. Here is an account on how the Synod was celebrated beginning from the 26<sup>th</sup> to 8<sup>th</sup> June.

## Participants of the Synod

A total of 121 delegates participated in the Diocesan Synod along with the bishop. These included 34 diocesan priests, 8 religious priests, 22 religious sisters from different congregations, and 57 lay faithful. From the five deaneries, 40 lay representatives (20 men and 20 women), 10 youth leaders (5 young men and 5 young women), 5 catechists, and 1 animator were chosen.

## The Working Document

To ensure fruitful and meaningful discussions during the synod, the bishop personally prepared the *Instrumentum Laboris*, the working

document, titled "*Discerning Synodal Pathways to Live as a Family of Believers*." The purpose of the synod was defined as listening to the inspiration of the Spirit, responding to the call of the Church, understanding the heartbeat of the people, hearing their hopes and expectations, and giving attention to the voices of the delegates. The working document has foreseen every minute detail concerning the content, time management methodology to be followed etc..Using this working document, the synod was successfully held from May 26 to May 30, 2025, where the delegates discussed various themes and shared their opinions.

## **Day 1: May 26, 2025**

The first day of the Diocesan Synod began with a solemn Eucharistic Celebration at 9:30 a.m. at Our Lady of Lourdes Cathedral in Kurnool, presided over by the bishop. Delegates consisting of priests, religious, and the faithful took part in the Mass. It was during this Mass that the bishop, who had announced the forthcoming synod on December 29, 2024, formally declared its inauguration in the presence of all delegates, other priests, religious and faithful. At the beginning of his homily Bishop formally declared the second Kurnool Diocesan Synod 2025 open. And then he also once again explained to those gathered the purpose for which he called the Synod. Then continued to remember the past Shepherds of the diocese, missionaries, priests, religious and Catechist that toiled to build the diocese and expressed his profound gratitude and appreciation. We are what we are today, thanks to their relentless missionary zeal and efforts, he said. Then commenting on the readings of the day he spoke of the early Christian community. There were internal conflicts in the early church. But the Apostles in communion and dialogue with the community resolved every form of conflict. There was dialogue, openness, willingness to solve the problems and live in communion. Luke narrates not only the problems but also the ways of resolving them. Thus gives a direction to the church of all times, said the Bishop.

The first session of the general assembly of the synod began at 11:30 a.m at the well equipped Jeevasudha Pastoral centre. It lasted for one and half hour. It was a conference given by the Bishop to remind the assembly of the purpose and objectives of the synod. Then he explained about the methodology that we follow in the synod. It was the method of Spiritual Conversations. He elaborated on the attitudes and dispositions one needs to have during these days. He urged all participants to create an atmosphere of prayer and to devote more time to spiritual reflection and attentive listening to one another.

Later in the afternoon, "Liturgical Life of the Diocese of Kurnool.", was the theme. The preparatory committee presented the existing situation in the diocese and proposed some guidelines and orientations for the future renewal and amendments. After the presentation, assembly was divided into groups to discuss on the questions already prepared for each group. After the group workshop, there was a general assembly to discuss in detail the proposals of the groups and other suggestions. Discussions revolved around reforms in the liturgy, ways to help the faithful better understand and participate in the sacraments, and how to spiritually prepare communities, especially for the Eucharist and the Sacrament of Matrimony. After detailed deliberations, some clear recommendations were put forth by the delegates.

## Day 2: May 27, 2025

The day began with the Holy Eucharist at 7 presided over by the College of consultors and Deans of the diocese. Fr. Prathapreddy celebrated the Mass, while Fr. Chowrappa delivered the homily. The second day's theme was "*Diocesan Pastoral Life.*" The focus was on evaluating the current pastoral programs of the diocese and formulating a new pastoral plan for the future. Suggestions were made to strengthen faith through family visits and social outreach programs. One important proposal was to divide parishes into smaller faith units or communities to ensure deeper pastoral care, better communication, and stronger faith formation at the grassroot level. Further

discussions were made on the role of Catechists, Animators, and also on the role of the Pastoral centre in the diocese. Speaking of the catechists, it was unanimously felt that they should be chosen from among the faithful and be properly trained. The youth should be made active participants in pastoral activities through games, quizzes, and other creative means to communicate Christian teachings. There were also discussions on how to utilize the diocesan pastoral center effectively and on the roles and responsibilities of its director.

### **Day 3: May 28, 2025**

On the third day, Rev. Dr. Mallavarapu Sundar celebrated the morning Mass. The day's theme was "Pastoral life in a parish". This consisted of discussions on forming parish pastoral councils, financial committees etc. Fr. Sundar who is specialized on the theme of Parish Pastoral councils explained the importance of establishing Pastoral and Financial Councils in every parish, helping delegates gain a deep understanding of their functioning. Extensive discussions followed on the administration of the parishes. There was unanimous agreement on the establishment of Parish Pastoral Councils and Finance Committees in every parish. Emphasis was placed on the moral and spiritual qualifications of those chosen as members. The delegates resolved that all decisions and financial transactions must be handled with transparency and accountability.

### **Day 4: May 29, 2025**

The religious priests present in the Synod presided over the Eucharistic celebration. Rev. Fr. Ajeesh VC celebrated the Mass while Fr. Uvari Antony SJ delivered the homily. The fourth day's theme was "social and educational apostolate in the diocese". Delegates reviewed the diocesan social service ministries and future action plans. Proposals were made to provide facilities for poor patients in hospitals, conduct skill development camps for youth, and raise awareness about government welfare schemes for the underprivileged. The educational ministry was also reviewed. Delegates

stressed the need for many reforms in the diocesan education system and strongly advocated for promoting digital learning, science, sports, and cultural activities. Everyone acknowledged the diocese's commendable efforts in providing education to poor children. The bishop assured that the diocese would continue supporting higher education and encouraged the establishment of new higher education institutions.

## **Day 5: May 30, 2025**

On the final day, the Eucharist was celebrated as usual at 7 am by the Bishop himself. The day was dedicated to temporal goods and the protection of the vulnerable. In the first session, the discussions and deliberations were on the ways to protect our lands and properties. Delegates suggested taking swift and systematic action to safeguard Church properties and advocated for digitizing all records. In the second session, the deliberations were about the ways of protecting the vulnerable in our Church and ecclesiastical premises. All felt the need to ensure that church premises be safe spaces for women and children. Every precaution has to be taken to protect the church from any form of abuses.

In the final moments of the general assembly, participants had the chance to express their feelings about the experience of these five days. They expressed joy in having learned many things about the diocese and appreciated the synod as a grace-filled experience.


On the same day, from 4:00 to 8:00 p.m., the bishop held a special session with the diocesan clergy to hear their views on priestly formation and well-being. Topics discussed included vocations, seminary formation, ongoing formation of the priests, and the overall welfare of the clergy. Priests shared their opinions freely and extensively. The day ended with the announcement of all the offices in the diocese as well as the transfers.

## Official Closing Ceremony of the Synod

June 8, 2025, remains a memorable day in the history of the Diocese of Kurnool. On the feast of Pentecost, the Diocesan Synod 2025 was officially concluded. His Eminence Cardinal Anthony Poola, the Archbishop of Hyderabad, presided over the concluding Holy Eucharist. During the closing Eucharist at Our Lady of Lourdes Cathedral, presided over by Cardinal Poola, Bishop Johannes Gorantla officially promulgated the post synodal document "**WALKING TOGETHER AS A FAMILY OF BELIEVERS**": *Pastoral guide of the Diocese of Kurnool*. This document includes diocesan



administrative policies, diocesan pastoral plan, liturgical reforms, the new parish administrative model, social and educational ministries, and protection of the vulnerable. The book was released by His Eminence Cardinal Poola Anthony.



## 1) COLLECTIONS IN BOARDING HOMES:

As per the policy of the Diocese, the boarding“in charges are allowed to collect from the DESK students only Rs. 3,000/- per year and the parents will be paying this amount in three installments. Kindly don’t“demand from the children more than this for any reason. If you have any kind of other collections apart from this please make known to the DESK. If there is any“change the DESK will intimate to you.

## 2) COLLECTIONS IN SCHOOLS:

School managements are strictly advised to follow the“Diocesan policies in collecting the fee from Catholic students. You have to collect only 50% of the monthly tuition school fees. There is no admission fee. If the same parents have three children studying in the same school the third child need not pay any fee of the 50% of the monthly tuition school fee. This provision does not“apply to children of the rich and of the government salaried parents. If there is any change the DESK will intimate to you.

## 3) FOR EASY COMMUNICATION:

Certainly, there will be some transfers in each“religious community therefore DESK would like to know the newly appointed“Boarding in charges, HM’s and Correspondents of your institutions. #### 4) DESK SELECTS NEW STUDENTS FOR SJRS:

DESK selected six students for SJRS for this academic year completing the selection process on June 7th. SJRS teachers and DESK Director interacted with the six year olds and their parents on June 7th at SJRS.

Diocesan Educational Society Kurnool (DESK) takes great care of Saint John's Residential School (SJRS). SJRS is a brainchild of late Bishop Johannes Gorantla, an educational institution of excellence to cater to the poor. It always keeps up its excellence. This school does not admit children of government employees and rich parents to cater only to the poor. Education here is absolutely free and the school provides for all the needs of the students.

DESK received a total of 31 applications this year. Ten of them were not eligible as they did not comply with the dates of birth or baptism and one did not come for the interview. All the other 20 appeared for interview and only six children passed. So these six children are selected in consultation with the Diocesan Bishop. DESK appreciates the parish priests who facilitated the admission of their poor children into this school which will change their future for good. Only 8 parishes took interest in their poor. DESK congratulates and appreciates these priests by naming their parishes: Alur, Bethemcherla, Gooty, Pedda Kadabur, Sambagal, Sirvel, Sunkeswari and Yemmiganur. The DESK sincerely thanks all the priests who cooperated with desk.

# FOUNDATION MASSES IN THE DIOCESE

When someone dies in our diocese, there is a possibility to the family to make a substantial donation to the diocese, which will fix it and use its interest to celebrate regular masses in memory of the deceased member, in whose name the foundation mass is established. To establish a foundation Mass, the minimum donation has to be Rs. 50,000.

- For a fixed amount of Rs. 50,000: The diocese will celebrate 6 Masses each year as long as the diocese exists. For a fixed amount of Rs. 100,000: The diocese will celebrate 12 masses every year, i.e. once a month on the date of demise.
- The Chancery will ensure and guarantee these celebrations
- A certificate will be granted to those who establish the foundation, signed by the Bishop and the Chancellor. Please inform this in our parishes and if anyone is interested please encourage them to contact the diocesan office.
